1. PERMIT FEES:

Fees for the year are **\$175.00** for adults and **\$25.00** for youth (17 & under).

2. GATED ROADS:

There are many gates on our lease. Do not park your vehicle in front of any gate and/or do not block any access road. Roads must be kept open for the gas company and any emergency.

3. PRIVATE PROPERTY:

Remember, your permit gives you permission to hunt on the leased property only. It does not give you permission to trespass on private land. There are a number of private tracts adjacent to or within our boundaries. If you wish to hunt these areas it will be your responsibility to obtain permission. (If you are unsure of the lines, a large format map [23"x35"] is available from *Action Graphics Printing and Sign Making* in Clearfield [814/765-1925] for \$10.00 - contact them to order.)

Please note: Posters reading Summit Resources, Brookville, PA are boundary posters for the lease. Eventually they will be replaced with blue & white posters of Black Hills Management LLC.

4. PERMITS & VEHICLE TAGS:

Your permit tag is two-part. One portion is to be displayed on your vehicle's rear view mirror. We realize you may have several vehicles. These tags can be moved from one vehicle to another. If your vehicle is found without a tag, a slip will be placed in your window to contact us within 24 hours. If we cannot identify your vehicle from information provided vehicle license data may be turned over for prosecution.

The other portion of the permit will be carried on your person. If you are asked to show it, please be courteous and do so. We will have people patrolling the lease to be sure everyone using the property is permitted. This is for your protection and enjoyment.

5. ATV OPERATION:

ATV's are permitted on the lease, however, each vehicle must be registered and insured according to PA rules and regulations. Before taking your ATV onto the lease you must obtain an ATV registration sticker from *Black Hills Management, LLC*. This allows us to keep track of all ATV vehicles.

When using your ATV, please use established trails and roads. **Do not** create new trails through the woods. The landowners' agents wish to keep trail damage and soil erosion to a minimum.

Be courteous during the hunting season. Please limit use of your ATV to accessing a given area. Excessive usage during the season could result in loss of your ATV tag. Be aware of other hunters and what they may be doing.

Occasionally a permit holder will be found in a situation that could lead to the revocation of their permit. Some items that could bring about this “unhappy circumstance” are:

- Bringing a non-permitted person onto the lease. During hunting season all hunters must have a permit to be on the lease.
- Committing any **Game Law** violation while on the lease. This includes but is not limited to such things as littering, hunting from a vehicle, abuse of alcoholic beverages, damage to property such as cutting trees, placing trees stands in trees with nails or careless use of fire.

These are some of the complaints we have had in past years. Remember, if your permit is revoked for any reason, there will be **no refund**. This will also exclude you from obtaining a permit in the future.

It is the goal of Black Hills Management, LLC to see that all permitted hunters enjoy the use of this lease. Cooperation by everyone is important. If you observe any violation and/or trespasser, please give us a call. (814) 592-6683

Welcome to the upcoming season! This year there is a new Permit Fee Schedule. Adult fees are \$175.00 for the year (June 1 to May 31) if purchased before September 1st. After September 1st the fee increases to \$190.00. Youth fees remain the same at \$25.00. **Permits will be distributed by mail only from Black Hills Management, LLC, P.O. Box 255, Reynoldsville, Pennsylvania 15851.**

Please return your application promptly. This insures you a permit for the coming year. **Applications received after November 1, will not be guaranteed for the first day of deer season.**

Also included is a request line for an ATV permit(s). *Only vehicles described by the rules and regulations published by the Department of Conservation and Natural Resources (DCNR) will be permitted.* Please be courteous during the hunting season and limit your recreational riding during that time.

INDEMNITY

I, the undersigned, being one of the licensees and permittees of a hunting and recreational use of lands lease for property located in Bell, Penn and Greenwood Townships, Clearfield County, Pennsylvania leased by Black Hills Management, LLC, hereby agree to save, indemnify, release and hold harmless the said Black Hills Management, LLC, their successors or assigns, from any claims, causes of action, suits or liabilities, including liabilities for all costs and attorney fees which may result because of any of the following:

- (a) Any act or omission on my part or the part of any guests or person acting through me or under my control on or related to the land use on Black Hills Management's leased properties.
- (b) Any matter generally which results from the usage of the land by me or any party as a guest or under my control for which a claim is asserted against the said Black Hills Management, LLC.

This indemnity is given in consideration of my right to use leased lands of Black Hills Management, LLC for recreational purposes, and I acknowledge that the execution of this agreement is a condition and prerequisite of the issuance of permission to use such lands. This indemnification will remain effective until withdrawn in written form and delivered to Black Hills Management, LLC at the above address. Upon withdrawal of this indemnity I will no longer be permitted the use of the property. It is my intention that this indemnity is binding upon me, my heirs, successors or assigns.
